7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Technical Communities, Inc., under GSA pricing, for a hardware and software upgrade to**  
9 **the QMatic system for customer flow management at the OhioMeansJobs Summit County**  
10 **Center, in a total amount not to exceed \$52,865.43, for the Office of Information**  
11 **Technology and the Executive's Department of Jobs and Family Services, and declaring an**  
12 **emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 16, 2017, awarded a  
15 purchase contract with Technical Communities, Inc., under GSA pricing, for a hardware and  
16 software upgrade to the QMatic system for customer flow management at the OhioMeansJobs  
17 Summit County Center, in a total amount not to exceed \$52,865.43; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned purchase contract with Technical Communities, Inc. is necessary and in  
21 the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a purchase contract with Technical Communities,  
29 Inc., under GSA pricing, for a hardware and software upgrade to the QMatic system for customer  
30 flow management at the OhioMeansJobs Summit County Center, in a total amount not to exceed  
31 \$52,865.43, is hereby confirmed and the County Executive is hereby authorized to execute such  
32 purchase contract and any related necessary documents.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further reason to immediately  
38 provide for a necessary hardware and software upgrade to the QMatic system for greater  
39 efficiency for customers at the OhioMeansJobs Summit County Center.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
