13 professional service contract with Community Legal Aid Services, Inc., for legal services, for a  
14 one-year term, for the period 10/1/17 through 9/30/18, in an amount not to exceed \$131,000.00,  
15 subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,  
18 that the aforementioned professional service contract with Community Legal Aid Services, Inc.  
19 is necessary and in the best interest of the County of Summit;
