7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Family and Community Services, Inc. for supportive services and temporary**
9 **financial assistance to U.S. military veteran families who are homeless or at risk for**
10 **becoming homeless, for a one-year term, from 10/1/17 through 9/30/18, in an amount not to**
11 **exceed \$100,000.00, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 16, 2017, awarded a
15 professional service contract with Family and Community Services, Inc. for supportive services
16 to U.S. military families who are homeless or at risk for becoming homeless, for a one-year term,
17 from 10/1/17 through 9/30/18, in an amount not to exceed \$100,000.00, subject to confirmation
18 by County Council; and

20 WHEREAS, this Council finds and determines after reviewing all pertinent information,
21 that the aforementioned professional service contract with Family and Community Services, Inc.
22 is necessary and in the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a professional service contract with Family and
30 Community Services, Inc. for supportive services and temporary financial assistance to U.S.
31 military veteran families who are homeless or at risk for becoming homeless, for a one-year
32 term, from 10/1/17 through 9/30/18, in an amount not to exceed \$100,000.00, is hereby
33 confirmed and the County Executive is hereby authorized to execute such professional service
34 contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason to immediately
40 provide supportive services and temporary financial assistance to U.S. military veteran families
41 who are homeless or at risk for becoming homeless effective 10/1/17.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
