7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide Supporting Partnerships to Assure**  
9 **Ready Kids services, for a one-year term, from 10/1/17 through 9/30/18, in an amount not**  
10 **to exceed \$55,000.00 for the Executive’s Department of Job and Family Services, and**

13 WHEREAS, the Board of Control, at its meeting held August 16, 2017, awarded a  
14 professional service contract with Greenleaf Family Center to provide Supporting Partnerships to  
15 Assure Ready Kids services, for a one-year term, from 10/1/17 through 9/30/18, in an amount  
16 not to exceed \$55,000.00, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
19 that the aforementioned professional service contract with Greenleaf Family Center is necessary  
20 and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The award by the Board of Control of a professional service contract with Greenleaf  
28 Family Center to provide Supporting Partnerships to Assure Ready Kids services, for a one-year  
29 term, from 10/1/17 through 9/30/18, in an amount not to exceed \$55,000.00, is hereby confirmed  
30 and the County Executive is hereby authorized to execute such professional service contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for Supporting Partnerships to Assure Ready Kids services to Summit County residents
