7 **A Resolution confirming an award by the Board of Control of a professional service**

12 WHEREAS, the Board of Control, at its meeting held August 16, 2017, awarded a
13 professional service contract to Mature Services, Inc., for adult employment services, for the
14 period 10/1/17 through 9/30/18, in an amount not to exceed \$120,000.00, subject to confirmation
15 by County Council; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,
18 that the aforementioned professional service contract with Mature Services, Inc. is necessary and
19 in the best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Mature
27 Services, Inc. for adult employment services, for the period 10/1/17 through 9/30/18, in an
28 amount not to exceed \$120,000.00 is hereby confirmed and the County Executive is hereby
29 authorized to execute such professional service contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for adult employment services effective 10/1/17.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
