7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the County of Summit Court of Common Pleas-Juvenile Division for Jobs**
9 **Reentry Program services, for a one-year term, from 10/1/17 through 9/30/18, in an amount**
10 **not to exceed \$115,000.00, for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 16, 2017, awarded an
14 intergovernmental agreement with the County of Summit, Court of Common Pleas-Juvenile
15 Division, for Jobs Reentry services, for a one-year term, from 10/1/17 through 9/30/18, in an
16 amount not to exceed \$115,000.00, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information
19 that the aforementioned intergovernmental agreement with the Court of Common Pleas-Juvenile
20 Division is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

25 SECTION 1

27 The award by the Board of Control of an intergovernmental agreement with the Court of
28 Common Pleas-Juvenile Division, for Jobs Reentry services, for a one-year term, from 10/1/17
29 through 9/30/18, in an amount not to exceed \$115,000.00, is hereby confirmed and the County
30 Executive is hereby authorized to execute such intergovernmental agreement.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to provide for Jobs
36 Reentry services for the Juvenile Division effective 10/1/17.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.




