7 **A Resolution authorizing the County Executive to execute a One-Stop Operator Services**  
8 **contract with the Summit and Medina Workforce Area Council of Governments pursuant**  
9 **to which the Executive's Department of Job and Family Services will provide One-Stop**  
10 **Operator services at the OhioMeansJobs Summit County Center, with a term commencing**  
11 **with the execution of the contract through 6/30/18, with two options to renew for an**  
12 **additional one-year term, for which the County shall be paid an amount not to exceed**  
13 **\$209,183.75, for the Executive's Department of Job and Family Services, and declaring an**  
14 **emergency.**

15  
16 WHEREAS, the U.S. Department of Labor's Employment and Training Administration  
17 funds a network of American Job Centers ("AJCs") to provide free employment assistance to job  
18 seekers at AJC network locations across the United States; and

19  
20 WHEREAS, pursuant to the requirements of Workforce Innovation and Opportunity Act  
21 of 2014 (the "WIOA") Section 121(d)(2)(A), Local Workforce Areas must competitively procure  
22 the Operators of AJCs; and

23  
24 WHEREAS, pursuant to requirements of the WIOA and on the behalf of the  
25 Summit/Medina Workforce Development Board (the "WDB"), Ohio Workforce Area 2 ("Area  
26 2") staff completed a competitive process to procure Operators for the Area's AJCs, known in the  
27 State of Ohio as OhioMeansJobs Centers, in Summit County as the OhioMeansJobs Summit  
28 County Center, and in Medina County as the OMJ Medina County Center; and

30 WHEREAS, based upon their evaluation of all submitted bids, the WDB's Performance  
31 Committee recommended at its 8/4/2017 meeting that the Summit and Medina Workforce Area  
32 Council of Governments (the "SAMWA COG") award a contract to the County Executive's  
33 Department of Job and Family Services ("DJFS") for the purpose of operating the Ohio Means  
34 Jobs Summit County Center; and

36 WHEREAS, the SAMWA COG adopted Resolution No. 2017-30, which is attached to  
37 this Resolution as Exhibit A, which confirmed the award of a One-Stop Operator Services  
38 contract to DJFS with a term commencing with the execution of the contract through 6/30/18,  
39 with two options to renew for an additional one-year term, for which the County shall be paid an  
40 amount not to exceed \$209,183.75; and

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
43 that it is necessary and in the best interest of the County of Summit to authorize the County  
44 Executive to execute a One-Stop Operator Services contract with the SAMWA COG pursuant to  
45 which DJFS will provide One-Stop Operator services at the OhioMeansJobs Summit County  
46 Center, with a term commencing with the execution of the contract through 6/30/18, with two  
47 options to renew for an additional one-year term, for which the County shall be paid an amount  
48 not to exceed \$209,183.75; and

50 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
51 of Ohio, that:

4 SECTION 1

5  
6 The County Executive is hereby authorized to execute a One-Stop Operator Services  
7 contract with the Summit and Medina Workforce Area Council of Governments ("SAMWA  
8 COG") pursuant to which the Executive's Department of Job and Family Services ("DJFS") will  
9 provide One-Stop Operator services at the OhioMeansJobs Summit County Center, with a term  
10 commencing with the execution of the contract through 6/30/18, with two options to renew for  
11 an additional one-year term, for which the County shall be paid an amount not to exceed  
12 \$209,183.75.

14 SECTION 2

15  
16 This Resolution is hereby declared an emergency in the interest of the health, safety and  
17 welfare of the citizens of the County of Summit, and for the further reason to immediately  
18 authorize the Executive to execute a necessary One-Stop Operator Services contract with the  
19 SAMWA COG, so that DJFS may immediately provide said services at the OhioMeansJobs  
20 Summit County Center.

22 SECTION 3

23  
24 Provided this Resolution receives the affirmative vote of eight members, it shall take  
25 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
26 effect and be in force at the earliest time provided by law.

28 SECTION 4

30 It is found and determined that all formal actions of this Council concerning and relating  
31 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
32 deliberations of this Council and of any of its committees that resulted in such formal action,  
33 were in meetings open to the public, in compliance with all legal requirements, including Section  
34 121.22 of the Ohio Revised Code.
