7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 (Communication Technician Unit) of**
9 **the American Federation of State, County and Municipal Employees, AFL-CIO, and the**
10 **County Executive and County Sheriff, for the period 4/1/17 through 3/31/20, which**
11 **authorizes a three percent (3.0%) increase in pay in each of the three years of the**
12 **agreement, for the Executive and the Sheriff, and declaring an emergency.**

14 WHEREAS, a collective bargaining agreement has been reached between the County
15 Executive and County Sheriff and Ohio Council 8 and Local 1229 (Communication Technician
16 Unit) of the American Federation of State, County and Municipal Employees, AFL-CIO, for the
17 period 4/1/17 through 3/31/20, which authorizes a three percent (3.0%) increase in pay in each of
18 the three years of the agreement; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
22 execute the aforementioned collective bargaining agreement;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

27 SECTION 1

29 The County Executive is hereby authorized to execute a collective bargaining agreement
30 between Ohio Council 8 and Local 1229 (Communication Technician Unit) of the American
31 Federation of State, County and Municipal Employees, AFL-CIO, and the County Executive and
32 County Sheriff, for the period 4/1/17 through 3/31/20, which authorizes a three percent (3.0%)
33 increase in pay in each of the three years of the agreement.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit and for the for the further reason of providing a
39 timely collective bargaining agreement between Ohio Council 8 and Local 1229
40 (Communication Technician Unit) of the American Federation of State, County and Municipal
41 Employees, AFL-CIO, and the County Executive and County Sheriff.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
