7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Environmental Design Group, LLC for professional engineering services for**
9 **Project Q-186 Elimination of Hudson Sanitary Sewer Overflow Area L, located in the City**
10 **of Hudson, in Council District 3, in an amount not to exceed \$427,336.19, and**
11 **appropriating funds, for the Executive's Department of Sanitary Sewer Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 30, 2017, awarded a
15 professional service contract with Environmental Design Group, LLC for professional
16 engineering services for Project Q-186 Elimination of Hudson Sanitary Sewer Overflow Area L,
17 located in the City of Hudson, in Council District 3, in an amount not to exceed \$427,336.19,
18 subject to confirmation by County Council; and

20 WHEREAS, is it necessary to appropriate funds for the aforementioned professional
21 service contract in the amount of \$854,672.38; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned professional service contract with Environmental Design Group, LLC is
25 necessary and in the best interest of the County of Summit and that it is further necessary and in
26 the best interest of the County of Summit to appropriate funds for said professional service
27 contract;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

34 The award by the Board of Control of a professional service contract with Environmental
35 Design Group, LLC for professional engineering services for Project Q-186 Elimination of
36 Hudson Sanitary Sewer Overflow Area L (the "Project"), located in the City of Hudson, in
37 Council District 3, in an amount not to exceed \$427,336.19, is hereby confirmed and the County
38 Executive is hereby authorized to execute such professional service contract.
