7 **A Resolution adjusting existing appropriations, in the amount of \$10,422.35, within the**  
8 **Community Corrections Act Adult Probation Intensive Supervision grant for State Fiscal**  
9 **Year 2017, ending 6/30/17, for the Executive's Department of Law, Insurance and Risk**  
10 **Management–Division of Public Safety, and declaring an emergency.**

11  
12 WHEREAS, County Council previously adopted Resolution No. 2016-240, which  
13 authorized the County Executive to execute any documents necessary to accept the award from  
14 the State of Ohio Department of Rehabilitation and Correction (“ODRC”), through the  
15 Community Corrections Act (“CCA”), of a 407 grant for State Fiscal Year 2017, in the amount  
16 of \$1,239,107.00, with no local cash match requirement, for community corrections programs to  
17 be operated by the Court of Common Pleas-Adult Probation Department and Oriana House, Inc.,  
18 for the period 7/1/16 through 6/30/17; and

20 WHEREAS, Council also previously adopted Resolution No. 2016-241, which  
21 authorized the County Executive to execute any documents necessary to accept the award from  
22 the ODRC, through the CCA, of a 408 grant for State Fiscal Year 2017, in the amount of  
23 \$516,759.00, with no local cash match requirement, for community corrections programs to be  
24 operated by the County Sheriff and Oriana House, Inc., for the period 7/1/16 through 6/30/17;

27 WHEREAS, the adjustment of existing appropriations, in the amount of \$10,422.35,  
28 within the Community Corrections Act Adult Probation Intensive Supervision grant for State  
29 Fiscal Year 2017, ending 6/30/17, is required to best meet the operational needs of the Court of  
30 Common Pleas-Adult Probation Department; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that the aforementioned appropriations adjustment is necessary and in the best interest of the  
34 County of Summit;

15 required to best meet the operational needs of the Court of Common Pleas-Adult Probation
