7 **A Resolution authorizing the County Executive to advertise for bids for 175 Full Face Piece**
8 **CBRNE Air Purifying Respirator Masks for Homeland Security Region 5 SWAT Teams,**
9 **for an estimated total cost not to exceed \$119,000.00, for the Executive's Department of**
10 **Law, Insurance and Risk Management-Division of Public Safety, and declaring an**
11 **emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

15
16 WHEREAS, the County Executive wishes to advertise for bids for 175 Full Face Piece
17 chemical, biological, radiological, nuclear and explosive materials ("CBRNE") Air Purifying
18 Respirators ("APR") Masks for Homeland Security Region 5 SWAT Teams, for an estimated
19 total cost not to exceed \$119,000.00; and

21 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that is necessary and in the best interest of the County of Summit to authorize the Executive to
26 advertise for bids for the aforementioned CBRNE APR Masks for Homeland Security Region 5
27 SWAT Teams;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The County Executive is authorized to advertise for bids for 175 Full Face Piece
35 chemical, biological, radiological, nuclear and explosive materials ("CBRNE") Air Purifying
36 Respirator ("APR") Masks for Homeland Security Region 5 SWAT Teams, for an estimated
37 total cost not to exceed \$119,000.00.

41 This Resolution is declared an emergency in the interest of the health, safety, and welfare
42 of the citizens of the County of Summit, and for the further reason that it authorizes the
43 Executive to immediately advertise for bids for the aforementioned necessary equipment for
44 Homeland Security Region 5 SWAT Teams so that said equipment may be obtained in a timely
45 manner.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
