7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the County Executive's Department of Job and Family Services of a**
9 **Federal Fiscal Year 2018 Temporary Assistance to Needy Families grant to the Court of**
10 **Common Pleas-Juvenile Division for its Family Resource Center, for the period 10/1/17**
11 **through 9/30/18, in the amount of \$419,799.00, with no local cash match requirement, and**
12 **appropriating funds, for the Court of Common Pleas-Juvenile Division, and declaring an**
13 **emergency.**

14
15 WHEREAS, the County Executive's Department of Job and Family Services has
16 awarded a Federal Fiscal Year 2018 ("FFY 2018") Temporary Assistance to Needy Families
17 ("TANF") grant to the Court of Common Pleas-Juvenile Division for its Family Resource
18 Center, for the period 10/1/17 through 9/30/18, in the amount of \$419,799.00, with no local cash
19 match requirement; and

21 WHEREAS, the Family Resource Center, which was established in 2006 through a grant
22 from DJFS, provides case management to at risk youth and their families who are involved in
23 domestic violence disputes, are pregnant or parenting teens, are teens at risk of dropping out of
24 school or are returning from long term stays at the Ohio Department of Youth Services, detention
25 or other placements; and

27 WHEREAS, pending before this Council is Resolution No. 2017-346, which confirms an
28 award by the Board of Control of an intergovernmental agreement with the Juvenile Division to
29 provide a youth and family strengthening program, for a one-year term, for the period 10/1/17
30 through 9/30/18, in an amount not to exceed \$419,799.00; and

32 WHEREAS, it is necessary to accept the award of the aforementioned FFY 2018 TANF
33 grant from DJFS and to appropriate said grant funds; and

35 WHEREAS, additional Helping Ohioans Move Expanding Choice grant funds, in the
36 amount of \$81,000.00, are available to supplement the FFY 2018 TANF grant funds; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
40 execute any documents necessary to accept the award of the aforementioned FFY 2018 TANF
41 grant from DJFS and to appropriate grant funds, in a total amount of \$500,799.00;

43 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State


