7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with the Akron Community Service Center and Urban League, Inc. to provide**  
9 **Career Pathways program services for adults ages 25 and older, including ex-offenders and**  
10 **non-offenders, for a one-year term, from 10/1/17 through 9/30/18, with one option to renew**  
11 **for an additional one-year term, in an amount not to exceed \$175,000.00, for the**  
12 **Executive's Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held September 6, 2017, awarded a  
15 professional service contract with the Akron Community Service Center and Urban League, Inc.  
16 to provide Career Pathways program services for adults ages 25 and older, including ex-  
17 offenders and non-offenders, for a one-year term, from 10/1/17 through 9/30/18, with one option  
18 to renew for an additional one-year term, in an amount not to exceed \$175,000.00, subject to  
19 confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
22 that the aforementioned professional service contract with the Akron Community Service Center  
23 and Urban League, Inc. is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

30 The award by the Board of Control of a professional service contract with the Akron  
31 Community Service Center and Urban League, Inc. to provide Career Pathways program  
32 services for adults ages 25 and older, including ex-offenders and non-offenders, for a one-year  
33 term, from 10/1/17 through 9/30/18, with one option to renew for an additional one-year term, in  
34 an amount not to exceed \$175,000.00, is hereby confirmed and the County Executive is hereby  
35 authorized such professional service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide for Career Pathways program services for adults ages 25 and older, including ex-  
42 offenders and non-offenders, effective 10/1/17.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take




