7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Opportunity Parish Ecumenical Neighborhood Ministry to provide job**
9 **readiness and employment advocacy services for youth aged 18-24, for a one-year term,**
10 **from 10/1/17 through 9/30/18, with one option to renew for an additional one-year term, in**
11 **an amount not to exceed \$137,900.00, for the Executive's Department of Job and Family**
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held September 6, 2017, awarded a
15 professional service contract with Opportunity Parish Ecumenical Neighborhood Ministry
16 ("OPEN M") to provide job readiness and employment advocacy services for youth aged 18-24,
17 for a one-year term, from 10/1/17 through 9/30/18, with one option to renew for an additional
18 one-year term, in an amount not to exceed \$137,900.00, subject to confirmation by County
19 Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information
22 that the aforementioned professional service contract with OPEN M is necessary and in the best
23 interest of the County of Summit;

30 The award by the Board of Control of a professional service contract with Opportunity
31 Parish Ecumenical Neighborhood Ministry ("OPEN M") to provide job readiness and
32 employment advocacy services for youth aged 18-24, for a one-year term, from 10/1/17 through
33 9/30/18, with one option to renew for an additional one-year term, in an amount not to exceed
34 \$137,900.00, is hereby confirmed and the County Executive is hereby authorized to execute such
35 professional service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 provide for job readiness and employment advocacy services for youth aged 18-24 effective

47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
