7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **AdvizeX Technologies, LLC, at less than State Term Pricing, for disaster recovery**  
9 **hardware bundle and VM licensing, for a three-year period, in a total amount not to exceed**  
10 **\$154,649.11, for the Office of Information Technology, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held August 30, 2017, awarded a  
13 purchase contract AdvizeX Technologies, LLC, at less than State Term Pricing, for disaster  
14 recovery hardware bundle and VM licensing, for a three-year period, approved by the IT Board  
15 8/28/2017, in an amount not to exceed \$154,649.11, subject to confirmation by County Council;

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the aforementioned purchase contract with AdvizeX Technologies, LLC is necessary and in  
20 the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

25 SECTION 1

27 The award by the Board of Control of a purchase contract with AdvizeX Technologies,  
28 LLC, at less than State Term Pricing, for disaster recovery hardware bundle and VM licensing,  
29 for a three-year period, approved by the IT Board 8/28/2017, in an amount not to exceed  
30 \$154,649.11, is hereby confirmed and the County Executive is hereby authorized to execute such  
31 purchase contract and any related necessary documents.

33 SECTION 2

35 This Resolution is hereby declared an emergency in the interest of the health, safety and  
36 welfare of the citizens of the County of Summit, and for the further reason to immediately  
37 provide for adequate disaster recovery for the County.

39 SECTION 3

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,  
50 were in meetings open to the public, in compliance with all legal requirements, including Section  
51 121.22 of the Ohio Revised Code.
