A Resolution confirming an award by the Board of Control of a professional service contract with Virgin Pulse, Inc. to provide wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan, for a one-year term, from 1/1/18 through 12/31/18, with two options to renew for additional one-year terms, for an estimated total amount not to exceed \$151,170.13, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, on behalf of the County of Summit, the County's consultant, NFP Corporate Services (OH), Inc., prepared and sent a request for proposals to vendors to provide wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan and the County has selected Virgin Pulse, Inc. as being the lowest responsive and responsible vendor; and

WHEREAS, the Board of Control, at its meeting held September 20, 2017, awarded a professional service contract to Virgin Pulse, Inc. to provide wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan, for a one-year term, from 1/1/18 through 12/31/18, with two options to renew for additional one-year terms, at a cost of \$5.28 per employee per month, for an estimated total amount not to exceed \$151,170.13; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Virgin Pulse is necessary and in the best interest of the County of Summit;
