7 **A Resolution confirming an award by the Board of Control of a blanket purchase order**
8 **with Ports Petroleum Co., Inc., for unleaded and diesel fuel for general fleet operations, for**
9 **the period 4/2/17 through 4/1/18, under CUE pricing, in an amount not to exceed**
10 **\$200,000.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held on September 13, 2017, awarded a
13 blanket purchase order with Ports Petroleum Co., Inc., for unleaded and diesel fuel for general
14 fleet operations, for the period 4/2/17 through 4/1/18, under CUE pricing, in an amount not to
15 exceed \$200,000.00, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the blanket purchase order with Ports Petroleum Co., Inc., for unleaded and diesel fuel for
19 general fleet operations is necessary and in the best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a blanket purchase order with Ports Petroleum Co.,
27 Inc., for unleaded and diesel fuel for general fleet operations, for the period of 4/2/17 through
28 4/1/18, under CUE pricing, in an amount not to exceed \$200,000.00, is hereby confirmed and the
29 County Executive is hereby authorized to execute such blanket purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety, and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide unleaded and diesel fuel for general fleet operations.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this council and of any of its committees that resulted in such formal action,
48 were in meetings open to the public, in compliance with all legal requirements, including Section
49 121.22 of the Ohio Revised Code.
