7 **A Resolution, pursuant to Section 4504.24 of the Ohio Revised Code, setting the**  
8 **dates for public hearings on proposed Ordinance No. 2017-430, which will enact**  
9 **Section 705.03 of the Codified Ordinances of the County of Summit, entitled**  
10 **“Third Additional Tax; Rate and Purpose” to levy an additional annual license tax**  
11 **of five dollars upon the operation of motor vehicles on the public roads and**  
12 **highways in Summit County for the purposes authorized in Section 4502.24(A)(2)**  
13 **of the Ohio Revised Code, and further directing the Clerk of Council to effectuate**  
14 **the proper publication and legal notice of said hearings, for the Engineer, and**  
15 **declaring an emergency.**

16  
17 WHEREAS, Section 4504.24(A)(1) of the Ohio Revised Code authorizes  
18 counties to levy an additional annual license tax of five dollars upon the operation of  
19 motor vehicles on the public roads and highways in that county. The additional tax  
20 shall be levied upon all motor vehicles the district of registration of which is located in  
21 Summit County, as defined in Section 4503.10 of the Ohio Revised Code. The tax  
22 levied under Section 4504.24(A)(1) is in addition to the tax levied by Sections 4503.02  
23 and 4503.07 of the Ohio Revised Code and any other taxes levied under Chapter 4504  
24 of the Ohio Revised Code. The rate of the tax is in addition to the tax rates prescribed  
25 in Sections 4503.04 and 4503.042 of the Ohio Revised Code, and is subject to  
26 reductions in the manner provided in Section 4503.11 of the Ohio Revised Code and  
27 the exemptions provided in Sections 4503.16, 4503.17, 4503.172, 4503.173, 4503.18,  
28 4503.41, 4503.43, 4503.46 and 4503.571 of the Ohio Revised Code; and

30 WHEREAS, the proceeds of the additional license tax levied pursuant to Section  
31 4504.24(A)(1) of the Ohio Revised Code shall be used for the purposes set forth in  
32 Section 4504.24(A)(2) of the Ohio Revised Code.

34 WHEREAS, the Executive and Engineer have proposed to levy the additional  
35 annual license tax of five dollars as set forth in Section 4504.24 of the Ohio Revised  
36 Code pursuant to Ordinance No. 2017-430.

37  
38 WHEREAS, pursuant to Section 4504.24(B) of the Ohio Revised Code, this  
39 Council is required to hold two public hearings prior to the adoption of Ordinance No.  
40 2017-430, and twice publish the date, time, and place of the public hearings in a  
41 newspaper of general circulation.

43 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of  
44 Summit, State of Ohio, that:

6 Pursuant to Section 4504.24 of the Ohio Revised Code, public hearings on  
7 Ordinance No. 2017-430, which would enact Section 705.03 of the Codified  
8 Ordinances of the County of Summit, entitled "Third Additional Tax; Rate and  
9 Purpose" to levy an additional annual license tax of five dollars upon the  
10 operation of motor vehicles on the public roads and highways in Summit County  
11 for the purposes authorized in Section 4502.24(A)(2) of the Ohio Revised Code,  
12 will take place on Monday, November 6, 2017 at 4:30pm and Monday, November  
13 13, 2017 at 4:30pm in Council Chambers, Ohio Building – 7th Floor, 175 South  
14 Main Street, Akron, Ohio.

18 Pursuant to Section 4504.24(B) of the Ohio Revised Code, the Clerk of Council is  
19 hereby directed to effectuate the publication of legal notice of the date, time, and place  
20 of the public hearings prescribed in Section 1 of this Resolution in a newspaper of  
21 general circulation in Summit County on Wednesday, October 18, 2017 and  
22 Wednesday, October 25, 2017.

26 This Resolution is hereby declared an emergency in the interest of the health,  
27 safety and welfare of the citizens of the County of Summit and for the further reason to  
28 fulfill publication and hearing requirements set forth in Section 4504.24(B) of the Ohio  
29 Revised Code prior to the adoption of a Resolution prescribed by Section 4504.24  
30 (A)(1) of the Ohio Revised Code.

32 SECTION 4

34 Provided this Resolution receives the affirmative vote of eight members, it shall  
35 take effect immediately upon its adoption and approval by the Executive; otherwise it  
36 shall take effect and be in force at the earliest time provided by law.

38 SECTION 5

40 It is found and determined that all formal actions of this Council concerning and  
41 relating to the adoption of this Resolution were adopted in an open meeting of this  
42 Council, and that all deliberations of this Council and of any of its committees that  
43 resulted in such formal action, were in meetings open to the public, in compliance with  
44 all legal requirements, including Section 121.22 of the Ohio Revised Code.
