7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a Safe Communities grant, from the Ohio Department of Public Safety**
9 **("ODPS"), in the amount of \$85,000.00, with no local cash match requirement, for the**
10 **period 10/1/17 to 9/30/18 and appropriating the grant funds, for the period 10/1/17 through**
11 **12/31/17, for the Sheriff, and declaring an emergency.**

13 WHEREAS, County of Summit Sheriff's Office has been awarded \$85,000.00, with no
14 local cash match requirement, from ODPS, through their Ohio Traffic Safety Office ("OTSO"),
15 in order to operate a Safe Communities Program in the County of Summit; and

17 WHEREAS, the Safe Communities grant is new to the Sheriff's Office, in the County of
18 Summit; and

20 WHEREAS, this Council has determined by reviewing all pertinent information that
21 authorizing the County Executive to execute any documents necessary to accept the
22 aforementioned grant, and the appropriations of the aforementioned grant funds, is necessary and
23 in the best interest of the County of Summit;
