7 **A Resolution temporarily moving up the date upon which the County may accept**
8 **applications for the registration/licensing of a dog for the year January 1, 2018 through**
9 **December 31, 2018 to November 4, 2017, the date upon which an Adopt-A-Thon will be**
10 **held at the County's Animal Control Facility, for the Executive's Department of**
11 **Administrative Services-Division of Animal Control, and declaring an emergency.**

13 WHEREAS, Section 955.01 of the Ohio Revised Code prescribes a period of time from
14 December 1st of the preceding year through January 31st of the succeeding year for the filing of
15 an application for the registration/licensing of a dog for that year commencing that January 1st;
16 and

18 WHEREAS, Section 955.01 further provide that this Council may extend the period of
19 time for the registration/licensing of dogs beyond the timeframe set forth in that section; and

20
21 WHEREAS, the County Executive's Department of Administrative Services- Division of
22 Animal Control will hold and Adopt-A-Thon at the County's Animal Control Facility on
23 Saturday, November 4, 2017; and

25 WHEREAS, it is necessary for this Council to authorize that the date upon which the
26 County may accept said application for the registration/licensing of a dog for the year January 1,
27 2018 through December 31, 2018 be temporarily moved up to November 4, 2017;

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information
30 that it is necessary and in the best interest of the County of Summit to temporarily move up the
31 date upon which the County may accept applications for the registration/licensing of a dog for
32 the year January 1, 2018 through December 31, 2018 to November 4, 2017, the date upon which
33 an Adopt-A-Thon will be held at the County's Animal Control Facility;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that:

40 This Council hereby authorizes the date upon which the County may accept applications
41 for the registration/licensing of a dog for the year January 1, 2018 through December 31, 2018 be
42 temporarily moved up to November 4, 2017, the date upon which an Adopt-A-Thon will be held
43 at the County's Animal Control Facility. Applications for the registration/licensing of a dog for
44 the year January 1, 2018 through December 31, 2018 shall only be accepted on November 4,
45 2017; thereafter, applications shall be accepted from December 1, 2017 through January 31,
46 2018 as set forth in Section 955.01 of the Ohio Revised Code and Sections 505.56 of the
47 Codified Ordinances of the County of Summit.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit and for the further reason that it is necessary in
8 order to immediately temporarily move up the date upon which the County may accept
9 applications for the registration/licensing of a dog for the year January 1, 2018 through
10 December 31, 2018 to November 4, 2017 to allow said applications to be accepted at the Adopt-
11 A-Thon to be held at the County's Animal Control Facility on said date.

15 Provided this Resolution receives the affirmative vote of eight members, it shall take
16 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
17 effect and be in force at the earliest time provided by law.

21 It is found and determined that all formal actions of this Council concerning and relating
22 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
23 deliberations of this Council and of any of its committees that resulted in such formal action,
24 were in meetings open to the public, in compliance with all legal requirements, including Section
25 121.22 of the Ohio Revised Code.
