7 **A Resolution approving the new classification and classification specification for the non-**
8 **bargaining classified position of GIS Technical/Applications Administrator 2, #28236, for**
9 **the Executive's Department of Human Resources, and declaring an emergency.**

11 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
12 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
13 Codified Ordinances to establish classifications and classification specifications for all County
14 employees; and

16 WHEREAS, at its September 21, 2017 meeting, at the request of the County Executive's
17 Department of Human Resources, the Human Resource Commission approved the new
18 classification and classification specification for the non-bargaining, classified position of GIS
19 Technical/Applications Administrator 2, #28236, as stated in Order 17-02, attached hereto as
20 Exhibit A; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 it is necessary and in the best interest of the County of Summit to approve the new classification
24 and classification specification for the non-bargaining, classified position of GIS
25 Technical/Applications Administrator 2, #28236;

40 classification is assigned the salary schedule of Category 3, Grade 7.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens and employees of the County of Summit, and for the further reason that it
46 is necessary in order to immediately approve the new classification and classification


