7 **A Resolution confirming an award by the Board of Control of a contract with Krumroy-**
8 **Cozad Construction, Inc. for the Probate Courtroom Renovation Project, located at 209 S.**
9 **High St., Akron, Ohio 44308, in Council District 4, in an amount not to exceed \$121,500.00,**
10 **for the Executive's Department of Administrative Services-Physical Plants Division, and**
11 **declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2017-298, which
14 authorized the County Executive to advertise for bids for the Probate Courtroom Renovation
15 Project, located at 209 S. High St., Akron, Ohio 44308, in Council District 4, for an estimated
16 total cost not to exceed \$149,700.00; and

18 WHEREAS, the Board of Control, at its meeting held October 11, 2017, awarded a
19 contract with Krumroy-Cozad Construction, Inc. for the Probate Courtroom Renovation Project,
20 in an amount not to exceed \$121,500.00; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned contract with Krumroy-Cozad Construction, Inc. is necessary and in the
24 best interest of the County of Summit;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The award by the Board of Control of a contract with Krumroy-Cozad Construction, Inc.
32 for the Probate Courtroom Renovation Project, located at 209 S. High St., Akron, Ohio 44308, in
33 Council District 4, in an amount not to exceed \$121,500.00, is hereby confirmed and the County
34 Executive is authorized to execute said contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
40 Executive to immediately commence the aforementioned Courthouse Facade Repair Project in
41 order to renovate the Probate Courtroom in a timely manner.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
