7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Motorola Solutions, Inc. for 22 portable radios and accessories for Tuscarawas County's**  
9 **Communications Interoperability Project, in an amount not to exceed \$67,456.40, for the**  
10 **Executive's Department of Law, Insurance and Risk Management-Division of Public**  
11 **Safety-Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2017-147, which authorized  
14 the County Executive to advertise for 22 portable radios and accessories for Tuscarawas  
15 County's Communication Interoperability Project, for an estimated total cost not to exceed  
16 \$86,163.00; and

18 WHEREAS, the Board of Control, at its meeting held October 11, 2017, awarded a  
19 purchase contract with Motorola Solutions, Inc. for 22 portable radios and accessories for  
20 Tuscarawas County's Communications Interoperability Project, in an amount not to exceed  
21 \$67,456.40, subject to confirmation by County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the aforementioned purchase contract with Motorola Solutions, Inc. is necessary and in the  
25 best interest of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that:

32 The award by the Board of Control of a purchase contract with Motorola Solutions, Inc.  
33 for 22 portable radios and accessories for Tuscarawas County's Communications Interoperability  
34 Project, in an amount not to exceed \$67,456.40, is hereby confirmed and the County Executive is  
35 hereby authorized to execute such purchase contract.

39 This Resolution is hereby declared an emergency in the interest of health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide necessary equipment for the Tuscarawas County.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
