7 **A Resolution adjusting existing appropriations, in the amount of \$2,317.00, within the**  
8 **Forensic Pathology Training Grant under the Paul Coverdell National Forensic Sciences**  
9 **Improvement Act of 2000, for the period 1/1/17 to 12/31/17, for the Executive - Department**  
10 **of the Medical Examiner, and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2017-144, which  
13 authorized the County Executive to execute any documents necessary to accept an award by the  
14 Ohio Department of Public Safety/Office of Criminal Justice Services of Forensic Pathology  
15 Training Gant under the Paul Coverdell National Forensic Sciences Improvement Act of 2000,  
16 for the period 1/1/17 through 12/31/17, in the amount of \$2,317.00, with no local cash match,  
17 and appropriated funds; and

19 WHEREAS, the adjustment of existing appropriations, in the amount of \$2,317.00,  
20 within the Forensic Pathology Training Grant, for the period 1/1/17 through 12/31/17, is required  
21 to best meet the needs of the Executive - Department of the Medical Examiner; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the aforementioned appropriations adjustment is necessary and in the best interest of the  
25 County of Summit;

16 121.22 of the Ohio Revised Code.


