7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract to E.L. Robinson Engineering, for professional design services for plans and**
9 **specifications to rehabilitate the load limited bridge on Riverview Rd, located in the City of**
10 **Cuyahoga Falls, Council District 3, in an amount not to exceed \$213,316.00, and**
11 **appropriating funds, for the Engineer, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 25, 2017, awarded a
14 professional service contract to E.L. Robinson Engineering, for professional design services for
15 plans and specifications to rehabilitate the load limited bridge on Riverview Rd, located in the
16 City of Cuyahoga Falls, Council District 3, in an amount not to exceed \$213,316.00, subject to
17 confirmation by County Council; and

19 WHEREAS, it is necessary to appropriate funds; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned professional services contract with E.L. Robinson Engineering is
23 necessary and in the best interest of the County of Summit;

30 The award by the Board of Control of a professional service contract to E.L. Robinson
31 Engineering, for professional design services for plans and specifications to rehabilitate the load
32 limited bridge on Riverview Rd, located in the City of Cuyahoga Falls, Council District 3, in an
33 amount not to exceed \$213,316.00, is hereby confirmed and the County Executive is hereby
34 authorized to execute such professional services contract.
