7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the State of Ohio Attorney General’s Office of a Federal Fiscal**
9 **Year 2018 Victims of Crime Act grant, in the amount of \$456,859.88, with a 20% local cash**
10 **match requirement of \$114,214.97, and a Federal Fiscal Year 201 State Victims Assistance**
11 **Act grant, in the amount of \$3,470.00, with no local cash match requirement, both for the**
12 **period of 10/1/17 through 9/30/18, and appropriating funds, for the Prosecutor, and**
13 **declaring an emergency.**

14
15 WHEREAS, the County Prosecutor has received an award from the State of Ohio
16 Attorney General’s Office of a Federal Fiscal Year (“FFY”) 2018 Victims of Crime Act
17 (“VOCA”) grant in the amount of \$456,859.88, with a 20% local cash match requirement of
18 \$114,214.97 to be paid from the Prosecutor-General Office General Fund, for the period 10/1/17
19 through 9/30/18; and

21 WHEREAS, the Prosecutor has also received an award from the State of Ohio Attorney
22 General’s Office of a FFY 2018 State Victims Assistance Act (“SVAA”) grant, in the amount of
23 \$3,470.00, with no local cash match requirement, for the period 10/1/17 through 9/30/18, and for
24 which the State of Ohio Attorney General’s Office requires an accounting identity separate from
25 the VOCA award; and

27 WHEREAS, the VOCA and SVAA are annual grants which help to support salary and
28 benefits for four full-time victim advocates, two part-time victim advocates, one full-time facility
29 dog handler, and part of the salary and benefits for a full-time supervisor; and

31 WHEREAS, the Prosecutor provides for the required VOCA grant match within her
32 annual budget; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the County
36 Executive to execute any documents necessary to accept the aforementioned grants from the
37 State of Ohio Attorney General’s Office and to appropriate funds;

47 cash match requirement of \$114,214.86, for the period 10/1/17 through 9/30/18.


