7 **A Resolution appropriating carryover funds, in the amount of \$1,679.68, in the Juvenile**
8 **Court's Ohio Supreme Court Innovation Grant, for Court of Common Pleas-Juvenile**
9 **Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 2016-202, which
12 authorized the County Executive to execute any documents necessary to accept the award of an
13 Innovation grant from the Ohio Supreme Court, for the period of 7/1/16 through 6/30/17, in an
14 amount of \$61,300.00, with no local match requirement, appropriated said grant funds, and
15 confirmed an award by the Board of Control of a related professional service contract with
16 RAHAB Ministries for the same period in an amount not to exceed \$61,300.00, for the Court of
17 Common Pleas- Juvenile Division; and

19 WHEREAS, the grant period has ended and a balance of \$1,679.68 in funds remain and it
20 is necessary to appropriate the said funds so they may be returned to the Ohio Supreme Court;

23 WHEREAS this Council finds and determines, after reviewing all pertinent information,
24 that appropriating carryover funds, in the amount of \$1,679.68, in the Juvenile Court's Ohio
25 Supreme Court Innovation Grant is necessary and in the best interest of the County of Summit;


6 Provided this Resolution receives the affirmative vote of eight members, it shall take
