7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Fallsway Equipment Company for one truck mounted forklift for the Ohio Region 5 Type**
9 **II Collapse Search and Rescue Team, in an amount not to exceed \$66,916.00, for the**
10 **Executive's Department of Law, Insurance and Risk Management-Division of Public**
11 **Safety-Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2017-127, which authorized
14 the County Executive to advertise for one truck mounted forklift for the Ohio Region 5 Type II
15 Collapse Search and Rescue Team, for an estimated total cost not to exceed \$158,500.00; and

17 WHEREAS, the Board of Control, at its meeting held November 8, 2017, awarded a
18 purchase contract with Fallsway Equipment Company for one truck mounted forklift for the
19 Ohio Region 5 Type II Collapse Search and Rescue Team, in an amount not to exceed
20 \$66,916.00, subject to confirmation by County Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned purchase contract with Fallsway Equipment Company is necessary and
24 in the best interest of the County of Summit;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The award by the Board of Control of a purchase contract with Fallsway Equipment
32 Company for one truck mounted forklift for the Ohio Region 5 Type II Collapse Search and
33 Rescue Team, in an amount not to exceed \$66,916.00, is hereby confirmed and the County
34 Executive is hereby authorized to execute such purchase contract.

38 This Resolution is hereby declared an emergency in the interest of health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason to immediately
40 provide necessary equipment for the Ohio Region 5 Type II Collapse Search and Rescue Team.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
