SECTION 1

The Clerk of Council shall set the date of December 4, 2017, at 4:30pm for the public hearing on the vacation, as required pursuant to Section 5553.045(C) of the Ohio Revised Code and Section 125.03(e) of the Codified Ordinances of the County of Summit, to determine whether the proposed vacation of Marvo Drive as requested by the Township Resolution would be for the public convenience or welfare.

SECTION 2

The Clerk of Council shall cause notice by regular U.S. mail to be made upon the abutting landowner(s) and Springfield Township informing them of the date set for the public hearing, and the Clerk shall comply with all notice requirements as set forth in Section 5553.045(C) of the Ohio Revised Code.

SECTION 3

The County Engineer shall submit a written report on the vacation containing the Engineer's opinion for or against the vacation prior to the December 4, 2017 hearing.

SECTION 4

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason of immediately allowing the County to comply with the requirements of Section 5553.045 of the Ohio Revised in a timely manner.

SECTION 5

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 6

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
