7 **A Resolution authorizing the Executive to execute an intergovernmental agreement with**
8 **the City of Akron concerning the Home Avenue Bridge Replacement, located in the City of**
9 **Akron, in Council District 4, for the Engineer, and declaring an emergency.**

11 WHEREAS, the County is removing and replacing the Home Avenue Bridge located in
12 the City of Akron, in Council District 4, near the intersection of Arlington and Home Avenue
13 (“Project”); and

14
15 WHEREAS, the City of Akron has requested the County include the replacement of a
16 water line under the bridge, the replacement of a sanitary sewer line adjacent to the bridge, and
17 the reconstruction/replacement of the traffic signal at the intersection as part of the Project; and

18
19 WHEREAS, an intergovernmental agreement is necessary to outline the duties and
20 financial commitments for the County of Summit and the City of Akron, as set forth in Exhibit
21 A; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that it is
24 necessary and in the best interest of the County of Summit to authorize the Executive to execute
25 an intergovernmental agreement with the City of Akron to for the aforementioned Project;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that;

30 SECTION 1

32 The County Executive is hereby authorized to execute an intergovernmental agreement
33 with the City of Akron to coordinate efforts and outline duties and financial responsibilities for
34 the Home Avenue Bridge Replacement Project, located in the City of Akron, in Council District
35 4. The County Executive is hereby authorized to execute said intergovernmental agreement in
36 substantially the form attached hereto as Exhibit A.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens of the County of Summit, and for the further purpose to immediately
42 authorize the Executive to execute an intergovernmental agreement necessary for the Home
43 Avenue Bridge Replacement Project to proceed.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
