WHEREAS, the County's Department of Job and Family Services ("DJFS") is the recipient of certain Fiscal Year 2017 ("FY 2017") Title XX/TANF and or Title XX Base funds, which it receives as part of its annual allocation; and

WHEREAS, DJFS anticipates receiving an allocation notice from the State of Ohio of FY 2017 Title XX/TANF and Title XX Base funds for DJFS for the period 10/1/16 through 9/30/17; and

WHEREAS, Summit County Children Services ("SCCS") provides protective services for children and emancipating out of foster care services that are eligible expenses for the use of Title XX/TANF funds; and

SECTION 1

The County Executive, through the Department of Job and Family Services, is hereby authorized to transfer an additional amount not to exceed \$500,000.00 in Title XX/TANF funds and/or Title XX Base funds, to Summit County Children Services ("SCCS"), for a total amount not to exceed \$1,200,000.00 including prior transfers, to be used for Non-Allocated Children's Services costs, and the County Executive is further authorized to execute any documents necessary to effectuate said transfer.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately authorize the transfer of said Title XX/TANF funds and/or Title XX Base funds to SCCS.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4
