7 **An Ordinance amending Section 141.01 of the Codified Ordinances of the County of**
8 **Summit, entitled “Continuation; Composition and Vacancies,” to change the composition**
9 **and terms of the County Planning Commission, for the Executive’s Department of Law,**
10 **Insurance and Risk Management, and declaring an emergency.**

11
12 WHEREAS, Section 141.01 of the Codified Ordinances of the County of Summit,
13 entitled “Continuation; Composition and Vacancies,” sets forth the composition and terms of the
14 members of the County Planning Commission; and

15
16 WHEREAS, in order to amend the composition and terms of the County Planning
17 Commission, it is necessary to amend Section 141.01; and

18
19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to amend Section 141.01 for
21 the aforementioned reason;

23 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

27
28 Section 141.01 of the Codified Ordinances of the County of Summit, entitled
29 “Continuation; Composition and Vacancies,” is hereby amended as follows:

30
31 **141.01 CONTINUATION; COMPOSITION AND VACANCIES.**

32 (a) The County Planning Commission, established pursuant to Ohio R.C. 713.22, shall
33 continue to exercise the powers and duties established by general law.

34
35 (b) The Planning Commission shall consist of nine (9) citizens of the County, and ~~one two~~
36 ~~District Representatives and one At-Large Representative~~ from Summit County Council. ~~The~~
37 ~~members of the Commission shall continue in their positions for their respective terms.~~
38 Vacancies shall be filled by appointment of the Executive pursuant to Section 2.03 (2) of the
39 County Charter.

40
41 (c) The terms for the ~~District Representatives and the At-Large Representative~~ from Summit
42 County Council shall run concurrently with the balance of the Representatives unexpired term.
43 All other members shall be appointed for a term of three (3) years with the current members if
44 the Commission continuing in their positions for the balance of their current terms. ~~commence~~
45 immediately and shall expire on December 31, 2004 and December 31, 2002 respectively. All
46 appointments for successor District Representatives and At-Large Representatives shall be for a
47 period of four years.

6 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
7 welfare of the citizens of the County of Summit and for the further reason that it is necessary to
8 immediately amend 141.01 of the Codified Ordinances of the County of Summit to modify the
9 composition and terms of the County Planning Commission.

11 SECTION 3

13 Provided this Ordinance received the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

17 SECTION 4

19 It is found and determined that all formal actions of this Council concerning and relating
20 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and of any of its committees that resulted in such formal action,
22 were in meetings open to the public, in compliance with all legal requirements, including Section
23 121.22 of the Ohio Revised Code.


