7 **An Ordinance amending Chapter 1307 of the Codified Ordinances of the County of**
8 **Summit, entitled “Fees” to increase the fees associated with the Summit County Building**
9 **Code, for the Executive’s Department of Community and Economic Development –**
10 **Division of Building Standards, and declaring an emergency.**

12 WHEREAS, Chapter 1307 of the Codified Ordinances of the County of Summit, entitled
13 “Fees,” establishes the fees associated with the Summit County Building Code; and

14
15 WHEREAS, it is necessary to amend Chapter 1307 to increase the fees associated with
16 the Summit County Building Code; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that it is necessary and in the best interest of the County of Summit to amend Chapter 1307 for
20 the aforementioned reason;

22 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
23 of Ohio, that:

25 SECTION 1

27 Effective February 1, 2018, Chapter 1307 of the Codified Ordinances of the County of
28 Summit, entitled “Fees,” is hereby amended as set forth in Exhibit A, attached to this Ordinance
29 and incorporated herein as if fully restated.

31 SECTION 2

33 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
34 welfare of the citizens of the County of Summit and for the further reason that it is necessary to
35 immediately amend Chapter 1307 of the Codified Ordinances of the County of Summit to
36 provide for an appropriate fee structure for the County as soon as possible.

40 Provided this Ordinance received the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
