7 **A Resolution authorizing the County Executive to execute Agreements of Cooperation for**
8 **Pavement Maintenance and/or Marking with County of Summit any political subdivision**
9 **that wishes to participate in County pavement maintenance and pavement marking**
10 **projects, for the Engineer, and declaring an emergency.**

11
12 WHEREAS, the County of Summit, through the County Engineer, regularly contracts for
13 pavement maintenance and pavement marking for roads within its area of responsibility; and

14
15 WHEREAS, County Council previously adopted Resolution No. 2011-181, which
16 authorized the County Executive to execute an Agreement of Cooperation for Pavement
17 Maintenance and/or Marking (the "Agreement") with County of Summit municipal corporations
18 that wish to participate in County pavement maintenance and pavement marking projects; and

19
20 WHEREAS, this Council recognizes that collaboration on pavement maintenance and/or
21 marking projects with other political subdivisions beyond municipal corporations will result in
22 cost advantages for all participants due to increased volume of materials required and scheduling
23 efficiencies for the service providers; and

25 WHEREAS, the County has further determined that a political subdivision's participation
26 in the pavement maintenance and/or pavement marking projects shall be operated on a cost-
27 neutral basis to the County and that accordingly, the participating political subdivisions shall be
28 responsible for certain costs and services for their portion of the projects, including but not
29 limited to necessary inspection, engineering and project design, field testing and inspection of
30 materials and services; and

32 WHEREAS, the County has determined that it is necessary to expand the authority of the
33 County Executive to execute the Agreement with any County political subdivisions; and

35 WHEREAS, this Council has determined by reviewing all pertinent information that it is
36 necessary and in the best interest of the County of Summit to authorize the County Executive to
37 execute the aforementioned Agreement with any County political subdivision that wishes to
38 participate in the County's pavement maintenance and pavement marking projects;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

43 SECTION 1

44
45 The County Executive is hereby authorized to execute Agreements of Cooperation for
46 Pavement Maintenance and/or Marking, as attached hereto as Exhibit A and incorporated herein
47 as if fully restated, with County of Summit political subdivisions that wish to participate in
48 County pavement maintenance and/or marking projects. The Agreement of Cooperation for
49 Pavement Maintenance and/or Marking is approved with changes therein not inconsistent with
50 this Resolution and not substantially adverse to the County which shall be approved by the
51 County Executive; provide that the approval of those changes by the County Executive and the
52 character of such changes as not being substantially adverse to the County shall be evidenced
53 conclusively by the execution of the Agreement of Cooperation for Pavement Maintenance
54 and/or Marking.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of Summit County and for the further reason to immediately enable the
8 County Executive to execute such contracts in order to improve efficiency and reduce costs.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
21 were in meetings open to the public, in compliance with all legal requirements, including section
22 121.22 of the Ohio Revised Code.
