7 **A Resolution authorizing the County Executive to advertise for bids for a specialized**
8 **flatbed heavy truck with a bed for the Ohio Region 5 Type II Collapse Search and Rescue**
9 **Team, for an estimated total cost not to exceed \$130,000.00, for the Executive's Department**
10 **of Law, Insurance and Risk Management Division of Public Safety-Emergency**
11 **Management Agency, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for a specialized flatbed
17 heavy truck with a bed for the Ohio Region 5 Type II Collapse Search and Rescue Team, for an
18 estimated total cost not to exceed \$130,000.00; and

20 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

23 WHEREAS this Council finds and determines, after reviewing all pertinent information
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 advertise for bids for the aforementioned flatbed heavy truck for the Ohio Region 5 Type II
26 Collapse Search and Rescue Team;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The County Executive is authorized to advertise for bids for a specialized flatbed heavy
34 truck with a bed for the Ohio Region 5 Type II Search and Rescue Team, for an estimated total
35 cost not to exceed \$130,000.00.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of Summit County, and for the further reason that it authorizes the
41 Executive to immediately advertise for the aforementioned necessary equipment for the Ohio
42 Region 5 Type II Collapse Search and Rescue Team in order to complete the project within the
43 grant period.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
