7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Contract Paper Group, Inc., in an amount not to exceed \$120,000.00, for the Executive's**
9 **Department of Finance and Budget-Office Services, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2018-031, which authorized
12 the County Executive to advertise for bids for the purchase of various types of office paper to
13 stock in 2018, for an estimated total cost not to exceed \$150,000.00; and

15 WHEREAS, the Board of Control, at its meeting held February 28, 2018, awarded a
16 purchase contract with Contract Paper Group, Inc., in an amount not to exceed \$120,000.00,
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the aforementioned purchase contract with Contract Paper Group, Inc., is necessary and in
21 the best interest of the County of Summit;

23 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

28 The award by the Board of Control of a purchase contract with Contract Paper Group,
29 Inc., for various types of office paper, in an amount not to exceed \$120,000.00, is hereby
30 confirmed and the County Executive is hereby authorized to execute such purchase contract.

34 This Resolution is hereby declared an emergency in the interest of health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide necessary office paper for various departments.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
49 were in meetings open to the public, in compliance with all legal requirements, including Section
50 121.22 of the Ohio Revised Code.

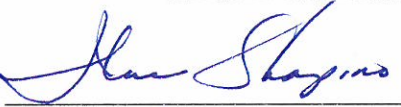
