7 **A Resolution authorizing the County Executive to advertise for bids for a five-year full**  
8 **maintenance service agreement for elevator maintenance at several County buildings, in**  
9 **Council Districts 2 and 4, for an estimated total cost not to exceed \$250,000.00, for the**  
10 **Executive's Department of Administrative Services-Physical Plants Division, and declaring**  
11 **an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for a five year full  
17 maintenance service agreement for 12 elevators located at 6 County maintained buildings  
18 (Summit County Courthouse, 2525 State Road, Summit County Jail, Summit County Summit  
19 Center, Summit County Board of Elections, and the Summit County Parking Deck), in Council  
20 Districts 2 and 4, for an estimated cost not to exceed \$250,000.00; and

22 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

25 WHEREAS this Council finds and determines, after reviewing all pertinent information  
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 advertise for bids for a five year full maintenance service agreement for 12 elevators located at 6  
28 County maintained buildings;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

33 SECTION 1

35 The County Executive is authorized to advertise for a five year full maintenance service  
36 agreement for 12 elevators located at 6 County maintained buildings, in Council Districts 2 and  
37 4, for an estimated total cost not to exceed \$250,000.00.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
43 Executive to immediately advertise for bids for the aforementioned elevator maintenance service  
44 agreement, in order to ensure that an agreement is in place prior to the current agreement's  
45 expiration date.


