7 **An amended Resolution authorizing the County Executive to execute any documents**  
8 **necessary to accept a fiscal year 2017 Edward Byrne Memorial Justice Assistance Grant**  
9 **from the Ohio Department of Public Safety, Office of Criminal Justice Services, in the**  
10 **amount of \$47,756.80, with no local cash match requirement, for the period 1/1/18 through**  
11 **12/31/18, and appropriating these grant funds, for the Executive's Department of Law,**  
12 **Insurance and Risk Management – Division of Public Safety, and declaring an emergency.**

14 WHEREAS, the Summit County Court of Common Pleas applied for and received a  
15 fiscal year 2017 Edward Byrne Memorial Justice Assistance Grant ("JAG") from the Ohio  
16 Department of Public Safety, Office of Criminal Justice Services, for the development and  
17 enhancement of programs within the criminal justice system; and

19 WHEREAS, these funds will be utilized to coordinate and enhance services to veteran  
20 clients who participate in Valor Court; and

21  
22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the County  
24 Executive to execute any documents necessary to accept the award of the aforementioned grant,  
25 and to appropriate these grant funds;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that:

32 The County Executive is hereby authorized to execute any documents necessary to accept  
33 fiscal year 2017 Edward Byrne Memorial Justice Assistance Grant ("JAG") from the Ohio  
34 Department of Public Safety, Office of Criminal Justice Services, in the amount of \$47,756.80,  
35 for the period 1/1/18 through 12/31/18, with no local cash match requirement.

28 121.22 of the Ohio Revised Code.


