7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award by the County of Summit Alcohol, Drug Addiction & Mental Health**  
9 **Services Board of a Reentry Coalition Grant, for a term from 3/15/18 through 6/30/18, in**  
10 **the amount of \$20,000.00, with no local cash match requirement, and appropriating funds,**  
11 **for the Court of Common Pleas – Reentry Court, and declaring an emergency.**

13 WHEREAS, the County of Summit Alcohol, Drug Addiction & Mental Health Services  
14 Board (“ADM Board”) has awarded the Court of Common Pleas – Reentry Court a Reentry  
15 Coalition Grant for a term from 3/15/18 through 6/30/18, in the amount of \$20,000.00, with no  
16 local cash match requirement for the operation of its Reentry Court; and

18 WHEREAS, said Reentry Coalition Grant Funds will be used for recovery support  
19 services that ensure successful offender reentry, reduce recidivism, enhance public safety,  
20 promote recovery, and eliminate barriers to treatment.

22 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
23 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
24 any documents necessary to accept the award from the ADM Board of the aforementioned  
25 Reentry Coalition Grant, and to appropriate the grant funds;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that:

32 The County Executive is hereby authorized to execute any documents necessary to accept  
33 the Reentry Coalition Grant by the County of Summit Alcohol, Drug Addiction & Mental Health  
34 Services Board (“ADM Board”) for a term from 3/15/18 through 6/30/18, in the amount of  
35 \$20,000.00, with no local cash match requirement.

11 SECTION 5




