7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Rolta AdvizeX Technologies, LLC, at below State Term Pricing, for a new HP Aruba core**
9 **datacenter switch and all necessary components, including hardware and maintenance**
10 **support, for a three-year term, in an amount not to exceed \$56,987.38, for the Office of**
11 **Information Technology, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its April 11, 2018 meeting, awarded a purchase
14 contract to Rolta AdvizeX Technologies, LLC, at below State Term Pricing, for a new HP Aruba
15 core datacenter switch and all necessary components, including hardware and maintenance
16 support, approved by the IT Board on 4/5/18, for a three-year term, in an amount not to exceed
17 \$56,987.38; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the aforementioned purchase contract with Rolta AdvizeX Technologies, LLC, in an amount
21 not to exceed \$56,987.38, is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

28 A purchase contract with Rolta AdvizeX Technologies, LLC, at below State Term
29 Pricing, for a new HP Aruba core datacenter switch and all necessary components, including
30 hardware and maintenance support, approved by the IT Board on 4/5/18, for a three-year term, in
31 an amount not to exceed \$56,987.38, is hereby confirmed and the County Executive is hereby
32 authorized to execute said purchase contract and any necessary related documents.

34 SECTION 2

36 This Resolution is declared an emergency in the interest of the health, safety and welfare
37 of the citizens of the County of Summit and for the further reason to immediately provide the
38 necessary datacenter and its components.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,
51 were in meetings open to the public, in compliance with all legal requirements, including Section
52 121.22 of the Ohio Revised Code.

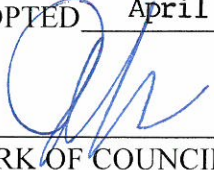

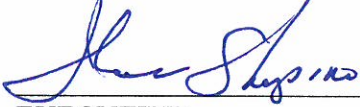
