7 **A Resolution approving and authorizing a salary adjustment for classified non-bargaining**
8 **employee Dan Hentosz, for the Executive's Department of Sanitary Sewer Services, and**
9 **declaring an emergency.**

11 WHEREAS, Section 169.07 of the Codified Ordinances of the County of Summit vest
12 this Council with the authority to approve any salary adjustments for job performance or pay
13 equity purposes for classified non-bargaining employees, upon the request of an appointing
14 authority; and

16 WHEREAS, Dan Hentosz, a classified non-bargaining employee with excellent work
17 performance in the Department of Sanitary Sewer Services currently performs similar job duties,
18 and has the same scope of responsibilities as other supervisors similarly situated within the
19 department, yet is compensated less than those similarly situated supervisors; and

21 WHEREAS, for purposes of pay equity and to recognize his job performance, the County
22 Executive has recommended that Dan Hentosz's salary be adjusted to be equivalent to the
23 similarly situated supervisors within the same classification; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary, and in the best interest of the County of Summit to approve the above-
27 referenced salary adjustment;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

34 The County Executive is hereby authorized to make the following salary adjustment for
35 Dan Hentosz, a classified non-bargaining employee in the Department of Sanitary Sewer
36 Services, effective May 28, 2018, upon the approval of the Director of the Department of Human
37 Resources and the certification of the availability of funds from the Director of the Department
38 of Finance and Budget, as required by Section 169.07(b):
