A Resolution authorizing the County Executive to execute an amendment to a Cooperative Agreement with the City of New Franklin wherein the County agreed to contribute towards the cost of the construction and easement acquisition for the Manchester Road Widening and Sanitary Sewer Extension Project, in the City of New Franklin, in Council District 7, to increase the County's contribution towards the same, and appropriating funds to provide for the increased contribution, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, pursuant to Resolution No. 2016-428, this Council authorized the County Executive to execute a Cooperative Agreement with the City of New Franklin to contribute towards the cost of construction and easement acquisition for the Manchester Road Widening and Sanitary Sewer Extension Project Q-834-2B ("Project"), in the City of New Franklin, in Council District 7, in an amount not to exceed \$583,701.51; and

WHEREAS, due to increases in the cost of the Project, the County's contribution towards the cost of the Project is expected to exceed the initial contribution amount of \$583,701.51 by an additional \$47,759.17, for a total amount not to exceed \$631,460.68; and

WHEREAS, it is necessary to execute an amendment to the aforementioned Cooperative Agreement to increase the amount of the County's contribution by an additional \$47,759.17, for a total amount not to exceed \$631,460.68; and

WHEREAS, it is further necessary to appropriate additional finds in the amount of \$47,759.17 to pay for the County's increased contribution; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned amendment to the Cooperative Agreement and to appropriate the necessary additional funds;
