WHEREAS, the County's current professional service contract with AccordWare, LLC for online employee benefit enrollment services terminates on 7/31/18;

WHEREAS, the County requested proposals from 13 vendors through the Division of Purchasing for online employee benefit enrollment services; and

WHEREAS, after receiving proposals from 5 vendors, AccordWare, LLC submitted the lowest responsive and responsible proposal, and the County's insurance consultant, NFP Corporate Services (OH), recommends that the County enter into a professional service contract with AccordWare, LLC, for online employee benefit enrollment services through its BenXpress system, for a one-year term, from 8/1/18 through 7/31/19, in an amount not to exceed \$121,000.00, with two options to renew for an additional one-year term;

WHEREAS, this Council finds and determines, after reviewing all pertinent information. that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned professional service contract with AccordWare, LLC, subject to the approval of the Board of Control;
