7 **A Resolution confirming an award by the Board of Control of professional service**  
8 **contracts between certain providers and the County's Department of Job and Family**  
9 **Services and the Summit and Medina Workforce Area Council of Governments to provide**  
10 **in-school and out-of-school youth employment and educational services under the**  
11 **Comprehensive Case Management and Employment Program, for the period 7/1/18 to**  
12 **6/30/19, with two options to renew, in a total amount not to exceed \$2,275,000.00, for the**  
13 **Executive's Department of Job and Family Services, and declaring an emergency.**

15 WHEREAS, the Board of Control, at its meeting held June 13, 2018, awarded  
16 professional service contracts between certain providers and the County's Department of Job and  
17 Family Services and the Summit and Medina Workforce Area Council of Governments to  
18 provide in-school and out-of-school youth employment and educational services under the  
19 Comprehensive Case Management and Employment Program, for the period 7/1/18 to 6/30/19,  
20 with two options to renew, in a total amount not to exceed \$2,275,000.00, as more fully set forth  
21 on Exhibit A, attached hereto and incorporated herein by reference, subject to confirmation by  
22 County Council; and

24 WHEREAS, as required by the Comprehensive Case Management and Employment  
25 Program, said professional service contracts will be funded by both Workforce Innovation and  
26 Opportunity Act funding through the Summit and Medina Workforce Area Council of  
27 Governments and Temporary Assistance to Needy Families funding through the County's  
28 Department of Job and Family Services; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County to enter into the aforementioned  
32 professional service contracts;

34 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

39 The award by the Board of Control of professional service contracts between certain  
40 providers and the County's Department of Job and Family Services and the Summit and Medina  
41 Workforce Area Council of Governments to provide in-school and out-of-school youth

43 Employment Program, for the period 7/1/18 to 6/30/19, with two options to renew, in a total  
44 amount not to exceed \$2,275,000.00, as more fully set forth on Exhibit A, attached hereto and  
45 incorporated herein by reference, is hereby confirmed and the County Executive is hereby  
46 authorized to execute said contracts.


