7 **A Resolution authorizing the County Executive to execute a one-year contract with the**  
8 **County of Summit Alcohol, Drug Addiction and Mental Health Services Board for the**  
9 **County Sheriff's Office to provide non-Medicaid behavioral health services through its**  
10 **Drug Abuse Resistance Education unit, for the period 7/1/18 through 6/30/19, for payment**  
11 **to the County in a total amount not to exceed \$86,900.00, for the Sheriff, and declaring an**  
12 **emergency.**

14 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services  
15 ("ADM") Board wishes to execute a one- year contract with the County for the County Sheriff's  
16 Office to provide non-Medicaid behavioral health services through its Drug Abuse Resistance  
17 Education ("DARE") unit, for the period 7/1/18 through 6/30/19, for which ADM has agreed to  
18 pay the County a total amount not to exceed \$86,900.00; and

20 WHEREAS, the County wishes to provide said services through the DARE unit; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that the aforementioned contract is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that;

30 The County Executive is hereby authorized to execute a one- year contract with the  
31 County of Summit Alcohol, Drug Addiction and Mental Health Services ("ADM") Board, which  
32 is attached hereto as Exhibit A and incorporated herein as if fully restated, for the County  
33 Sheriff's Office to provide non-Medicaid behavioral health services through its Drug Abuse  
34 Resistance Education ("DARE") unit, for the period 7/1/18 through 6/30/19, for payment to the  
35 County of a total amount not to exceed \$86,900.00.

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
40 welfare of the residents of the County of Summit and for the further purpose of immediately  
41 authorizing the Sheriff Office to provide non-Medicaid behavioral health services through the  
42 Sheriff Office's DARE unit to the ADM Board from 7/1/18 through 6/30/19.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
