WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services ("ADM") Board wishes to execute a one-year contract with the County for the County Sheriff's Office to provide non-Medicaid behavioral health services through its Drug Abuse Resistance Education ("DARE") unit, for the period 7/1/18 through 6/30/19, for which ADM has agreed to pay the County a total amount not to exceed \$86,900.00; and

WHEREAS, the County wishes to provide said services through the DARE unit; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is hereby authorized to execute a one- year contract with the County of Summit Alcohol, Drug Addiction and Mental Health Services ("ADM") Board, which is attached hereto as Exhibit A and incorporated herein as if fully restated, for the County Sheriff's Office to provide non-Medicaid behavioral health services through its Drug Abuse Resistance Education ("DARE") unit, for the period 7/1/18 through 6/30/19, for payment to the County of a total amount not to exceed \$86,900.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the further purpose of immediately authorizing the Sheriff Office to provide non-Medicaid behavioral health services through the Sheriff Office's DARE unit to the ADM Board from 7/1/18 through 6/30/19.
