12 WHEREAS, the County Executive wishes to advertise for bids for a three-year purchase
13 contract for uniform services, with one option to renew for an additional three years, for an estimated
14 total cost not to exceed \$110,000.00, for the Executive's Department of Administrative Services-
15 Physical Plants Division, Department of Sanitary Sewer Services, Division of Animal Control, and
16 Division of Building Standards; and

18 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires
19 this Council's authorization for the County Executive to advertise for bids; and

21 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office; and

23 WHEREAS this Council finds and determines, after reviewing all pertinent information that
24 it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 advertise for bids for the aforementioned purchase;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of
28 Ohio, that:

32 The County Executive is authorized to advertise for a three-year purchase contract for
33 uniform services for the Executive's Department of Administrative Services-Physical Plants
34 Division, Department of Sanitary Sewer Services, Division of Animal Control, and Division of
35 Building Standards, with one option to renew for an additional three years, for an estimated total cost
36 not to exceed \$110,000.00.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the residents of the County of Summit, and for the further reason that it authorizes the
42 Executive to immediately advertise for bids for the aforementioned uniform services, in order to
43 provide necessary uniforms to various County employees.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
48 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in
49 force at the earliest time provided by law.




