7 **An amended Resolution authorizing the County Executive to execute an intergovernmental**  
8 **agreement with the County of Summit Alcohol, Drug Addiction and Mental Health**  
9 **Services Board (“ADM”) to accept a Specialized Docket Subsidy, for the period 7/1/18**  
10 **through 6/30/19, in the amount of \$140,000.00, with no local cash match requirement, and**  
11 **appropriating funds, for the Court of Common Pleas-General Division, and declaring an**  
12 **emergency.**

14 WHEREAS, the Ohio Department of Mental Health and Addiction Services  
15 (“ODMHAS”) has allocated specialized docket subsidies to the County of Summit Alcohol,  
16 Drug Addiction and Mental Health Services Board (“ADM”) to assist drug courts and other  
17 specialized dockets with funding to effectively manage addicted offenders in the community; and

18  
19 WHEREAS, it is necessary to authorize the County Executive to execute an  
20 intergovernmental agreement with ADM to accept a Specialized Docket Subsidy from ADM to  
21 the Court of Common Pleas-General Division for the period 7/1/18 through 6/30/19, in the  
22 amount of \$140,000.00, with no local cash match requirement; and

24 WHEREAS, it is necessary to appropriate the funds the County will receive pursuant to  
25 said Intergovernmental Agreement; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
29 execute ~~any documents necessary to accept the aforementioned grant funds from ADM~~ said  
30 Intergovernmental Agreement and appropriate funds;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

37 The County Executive is hereby authorized to execute an intergovernmental agreement

40 \$140,000.00, for the Court of Common Pleas-General Division.
