7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Zones Inc., for 75 ruggedized tablets, for a total amount not to exceed \$259,846.50, for the**
9 **Executive's Department of Law and Risk Management-Division of Public Safety, and**
10 **declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2018-255, which authorized
13 the County Executive to advertise for bids for 75 ruggedized tablets with, for an estimated total
14 cost not to exceed \$338,000.00; and

16 WHEREAS, the Board of Control, at its meeting held August 29, 2018, awarded a
17 purchase contract with Zones Inc., for 75 ruggedized tablets, for a total amount not to exceed
18 \$259,846.50, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned purchase contract with Zones Inc. is necessary and in the best interest of
22 the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a purchase contract with Zones Inc., for 75
30 ruggedized tablets, for a total amount not to exceed \$259,846.50, is hereby confirmed and the
31 County Executive is hereby authorized to execute such purchase contract.

33 SECTION 2

35 This Resolution is hereby declared an emergency in the interest of health, safety and
36 welfare of the residents of the County of Summit, and for the further reason to immediately
37 authorize a necessary purchase contract for the aforementioned ruggedized tablets.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
50 were in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.


