7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Opportunity Parish Ecumenical Neighborhood Ministry to provide job**
9 **readiness services for work mandated able-bodied adults without dependents, for a one-**
10 **year term, from 10/1/18 through 9/30/19, with one option to renew for an additional one-**
11 **year term, in an amount not to exceed \$138,000.00, for the Executive's Department of Job**
12 **and Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held September 19, 2018, awarded a
15 professional service contract with Opportunity Parish Ecumenical Neighborhood Ministry
16 ("OPEN M") to provide job readiness services for work mandated able-bodied adults without
17 dependents receiving Food Assistance Employment and Training ("FAET") program benefits,
18 for a one-year term, from 10/1/18 through 9/30/19, with one option to renew for an additional
19 one-year term, in an amount not to exceed \$138,000.00, subject to confirmation by County
20 Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information
23 that the aforementioned professional service contract with OPEN M is necessary and in the best
24 interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The award by the Board of Control of a professional service contract with Opportunity
32 Parish Ecumenical Neighborhood Ministry ("OPEN M") to provide job readiness services for
33 work mandated able-bodied adults without dependents receiving Food Assistance Employment
34 and Training ("FAET") program benefits, for a one-year term, from 10/1/18 through 9/30/19,
35 with one option to renew for an additional one-year term, in an amount not to exceed
36 \$138,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
37 professional service contract.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further reason to immediately
43 provide for job readiness services for work mandated able-bodied adults without dependents
44 effective 10/1/18.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.


